**MALAYSIA–UNITED ARAB EMIRATES COMPREHENSIVE ECONOMICS PARTNERSHIP AGREEMENT
(MY-UAE CEPA)**

Reference is made by the [ANNOUNCEMENT](#) by the Ministry of Investment, Trade and Industry (MITI), Malaysia on 29 September 2025. The Malaysia–United Arab Emirates Comprehensive Economic Partnership Agreement (MY-UAE CEPA) had officially entered into force for Malaysia on **1 October 2025**. Malaysian exporters will be able to apply for the Preferential Certificate of Origin (PCO) for exports to the United Arab Emirates (UAE), as well importing raw materials from UAE.

The CEPA covers wide areas of co-operations including trade of goods and services, investments, digital trade, SME corporations, Islamic economy and Government procurement.

1. TARIFF REDUCTION SCHEDULE FOR PLASTIC RAW MATERIALS IMPORTING FROM UAE

Import duties for major type of plastic resins will be reduced gradually to 0% over a period of six years, summarised as follows:

Import duties for all types of plastic products will be reduced gradually to 0% over a period of six years, summarised as follows:

Import duties for all types of plastic products will be reduced gradually to 0% over a period of six years, summarised as follows:
