## Explanatory Notes

### 1. Eligibility

Any person, firm or company engaged in the supply of machinery or goods or services or in the sale of products of any plastic manufacturer may become an **ASSOCIATE** member of the Association.

### 2. Membership Fees

#### 2.1 Entrance Fees

The Entrance Fees of RM250.00 is a one-time payment for MPMA membership.

#### 2.2 Annual Subscription

The annual subscription payable by an ASSOCIATE member shall be RM1,500.00.

- Billing is on an annual basis.
- Once membership application has been approved, the company will be notified to make payment.

### 3. Requirements

- Application for membership should be made by completing the Membership Registration Form and submitting it with certified copies of the following documents:
  - For Sole Proprietor/Partnership : Forms D & A or D & B
  - For Incorporated Companies : Forms 24 & 49 or 49, 9 & 13
  - For Non-Malaysian Companies : Forms 79, 80, 83 & 83A
- Once the Membership Registration Form and documents are in order, the Secretariat will submit to MPMA Central Committee for approval and once it is approved, the Secretariat will issue invoice for payment.

### 4. Resignation

- Members who choose to resign are requested to provide the reasons for resignation to the Secretariat.
- All outstanding membership fees must be paid prior to resignation.
